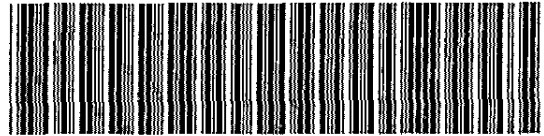


ARTICLE IV -- MANAGEMENT


