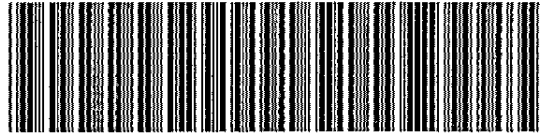

ARTICLE I

NAME

INDEMNIFICATION

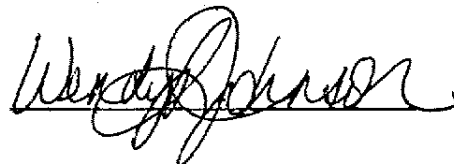

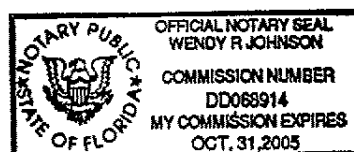

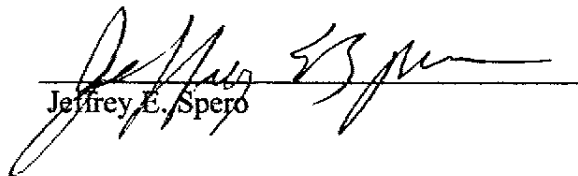
