ARTICLES OF ORGANIZATION of BK & K, LLC

We, the undersigned as organizers of a limited liability company, under the Florida Limited Liability Company Act pursuant to Chapter 608, Florida Statutes, adopt the following Articles of Organization for such limited liability company:

- 1. Name. The name of the limited liability company is BK & K, LLC.
- 2. <u>Purpose</u>. The purpose of this limited liability company may include the transaction of any and all lawful business for which limited liability companies may be organized in the state of Florida.
- 3. <u>Powers.</u> The limited liability company shall have the same powers as an individual to do all things necessary to carry out its business and affairs, including, without limitation, the power to:

conduct, promotion, or attainment of the business of the contracting limited liability company; or make other contract of guaranty and suretyship which are necessary or convenient to the conduct, promotion, or attainment of the business of the contracting limited liability company.

- (f) Lend money, invest or reinvest its funds, and receive and hold real or personal property as security for repayment.
- (g) Conduct its business, locate offices, and exercise the powers granted by Chapter 608, Florida Statutes, within or without this state.
