



#### ARTICLES OF ORGANIZATION

STANDARD OF THE PARTY OF THE PA Pursuant to the Provisions of the Florida Statutes, the undersigned organizer hereby the following Limited Liability Company Articles of Organization.

#### ARTICLE I NAME

The name of the limited liability company is **DUMOR PROPERTIES, LLC** (the "Company").

#### ARTICLE II **DURATION**
