# ARTICLES OF ORGANIZATION OF THOMAS R. CONKLIN – ATTORNEY & COUNSELOR A PROFESSIONAL LIMITED LIABILITY COMPANY

The undersigned, a member or authorized representative, hereby subscribes to these Articles of Organization to form a professional limited liability company (the "Company") under the Florida Limited Liability Company Act (Chapter 608, Florida Statutes), the Florida Professional Service Corporation and Limited Liability Company Act (Chapter 621, Florida Statutes) and in accordance with section 608.407, Florida Statutes.

- 1. Name. The name of the Company is Thomas R. Conklin Attorney & Counselor A Professional Limited Liability Company.
  - 3. <u>Purposes.</u> The purposes for which the Company is organized are as follows:
