## ARTICLES OF AMENDMENT OF VILLAGE OAKS OF WAUCHULA, LLC

- 1. The Articles of Organization of VILLAGE OAKS OF WAUCHULA, LLC, were filed on March 28, 2005, and assigned document number L05000030623.
  - Article V is hereby amended to read as follows:

- 2. File a potition in bankruptcy, make a general assignment for the benefit of creditors or application for other such relief available under similar laws or regulations, or,

  - 4. Hire, terminate, or modify the terms of employment of any Manager, or;
- 5. Cause this Company to enter into a joint venture or partnership with any other person or entity, or;
