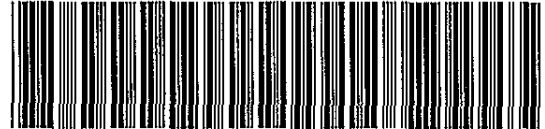



**ARTICLE I  
Name**


**ARTICLE VIII**


