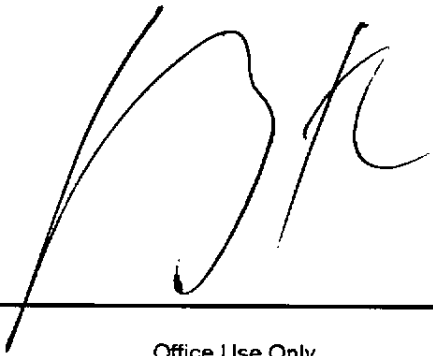

OF

The undersigned subscribes to these Articles of Organization for the purpose of forming a limited liability company under the laws of the State of Florida.

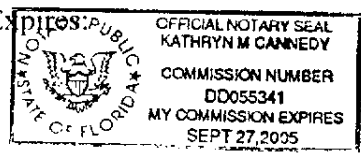

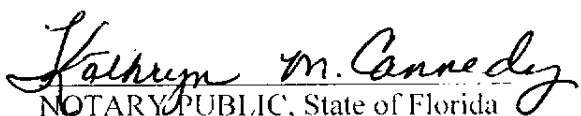

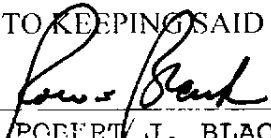
