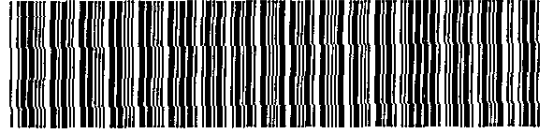

The name of the Limited Liability Company is MC 144 HOLDINGS, LLC (the "Company").


