**ARTICLES OF ORGANIZATION
CHRISTIAN COUNSELING SERVICES, LLC**

The undersigned member, desiring to form a Limited Liability Company under and pursuant to Chapter 608, Florida Statutes, entitled the Florida Limited Liability Company Act (the "Act"), does hereby adopt the following Articles of Organization for such Company:

1. **Name.** The name of this limited liability company is CHRISTIAN COUNSELING SERVICES, LLC ("Company").
2. **Purpose.** The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida and that are permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.
3. **Registered Agent and Office.** The name of the initial registered agent of the Company is William C. Davell. The street address of the initial registered agent of the Company is c/o May, Meacham & Davell, P.A., One Financial Plaza, Fort Lauderdale, FL 33394.
4. **Principal Office: Mailing Address and Street Address.** The street address and mailing address of the Company's principal office is 4200 SW 54 Court, Fort Lauderdale, FL 33314.
5. **Management of the Company.** The business of the Company shall be managed by its members and is, therefore, a member-managed company.
6. **Initial Members.** The name and address of the initial member as follows:

9. **Transfer of Interest and Admission of Additional Members.** No member shall have the right to transfer any interest in the Company unless said member follows the procedures as provided in the Operating Agreement. Additional members shall only be admitted pursuant to the terms and conditions of the Operating Agreement.

10. **Certificated Interests.** The members' membership interests in the Company may be evidenced by certificates.
