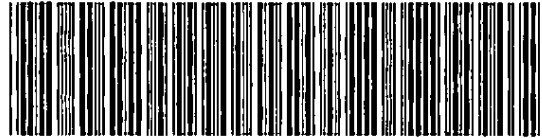

**AMENDMENT TO
ARTICLES OF ORGANIZATION
OF
ALBRITTON INSURANCE SERVICES, L.L.C.**

The Articles of Organization for Albritton Insurance Services, L.L.C. are amended pursuant to Section 608.411, Florida Statutes as follows:

1. Name. The current name of this limited liability company is Albritton Insurance Services, L.L.C. ("Company").
2. Date of Filing Initial Articles of Organization. The Company's initial Articles of Organization were filed on March 30, 2005 (L05000031111).
3. Amendment. Article I is deleted and replaced with the following:

ARTICLE I

The name of the limited liability company is hereby changed to Community Insurance Group, LLC ("Company").

4. Amendment. Article II is deleted and replaced with the following:

ARTICLE II

The Company shall exist perpetually, unless sooner dissolved in accordance with the Company's Regulations, Operating Agreement, or Florida law.

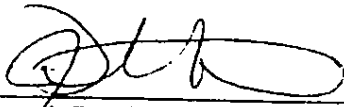
5. Amendment. Article III is deleted and replaced with the following:

ARTICLE III

The primary purpose of the Company shall be to engage, directly or indirectly, in any and all types of lawful business for which limited liability companies may be organized under the Florida Revised Limited Liability Company Act (Chapter 605, Florida Statutes).

6. In all other respects the Company's Articles of Organization are hereby ratified.
