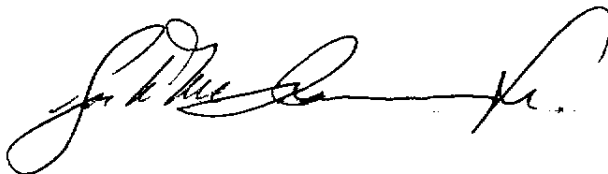

**ARTICLE I – NAME**

The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of the state of Florida.

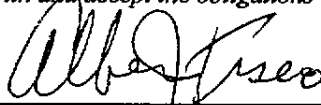
**ARTICLE IV – DURATION**
