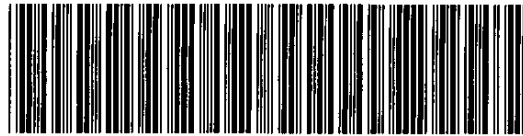

All debts, obligations and liabilities of the Company have been paid or discharged, or adequate provision has been made therefore pursuant to Section 608.4421 of the Act.

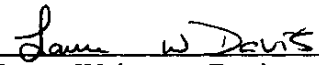
## **ARTICLE V – DISTRIBUTION OF COMPANY PROPERTY**
