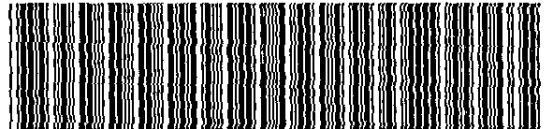



**ARTICLES OF ORGANIZATION OF**  
**3179 GATEWAY LANE, LLC**

The undersigned hereby makes, subscribes, and files these Articles of Organization for the purpose of forming a limited liability company under the Florida Limited Liability Company Act:

1. **Name.** The name of the limited liability company is **3179 GATEWAY LANE, LLC.**
2. **Duration.** The period of duration of the limited liability company is perpetual.
3. **Principal Office.** The mailing address and the street address of the principal office of the limited liability company is, c/o Ian David Silverman, 928 Manatee Way, Hollywood, Florida 33019
