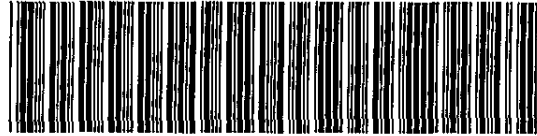

**ARTICLES OF ORGANIZATION OF STEWBAY, LLC
FLORIDA LIMITED LIABILITY COMPANY**

**THE UNDERSIGNED, BEING AUTHORIZED TO EXECUTE
AND FILE THESE ARTICLES OF ORGANIZATION, HEREBY
CERTIFIES THAT:**

ARTICLE I – Name:

The name of the Limited Liability Company (hereinafter referred to as the “Company”) is “STEWBAY, LLC”.

ARTICLE II – Address:


