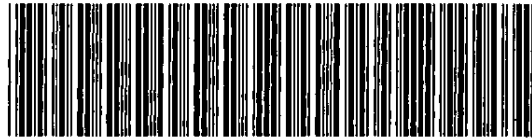

**ARTICLES OF AMENDMENT TO THE
ARTICLES OF ORGANIZATION OF
BNT HOLDINGS, LLC.**

Pursuant to the provisions of Section 608.411 of the Florida Limited Liability Company Act, the undersigned limited liability company adopts the following Articles of Amendment to its Articles of Organization:

Article 1 - Name of Limited Liability Company

The name of the limited liability company shall be known as **THE YOGA-SANCTUARY, LLC**, rather than BNT HOLDINGS, LLC. Specifically, Article 1 of the originally filed Articles of Organization filed on April 1, 2005, shall be amended to that extent only. The mailing address for the LLC shall remain as originally filed, which is 1133 Bal Harbor Drive, Unit 1139, Punta Gorda, FL 33950. Also, any other reference to the name of the LLC in said originally filed Articles of Organization and Certificate of Designation of Registered Agent is hereby amended. The date of adoption of the amendment was the 27th day of February, 2007, and the number of votes cast for the amendment (100%) was sufficient for approval.

Article 2 - Balance of Articles

The balance of the Articles of Organization shall remain as originally filed.

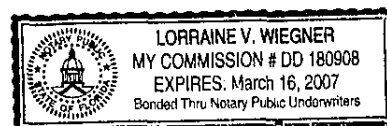
