ARTICLES OF ORGANIZATION OF

THREE POINT AVIATION, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act; F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME
