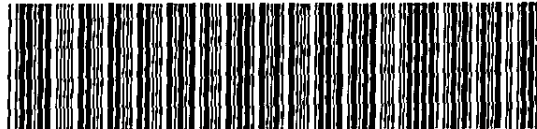

1. Name. The name of this limited liability company is Cooper Street, LLC, a Florida limited liability company (the "Company").

2. Duration. The Company shall have perpetual existence, commencing upon the date of filing of these Articles with the Florida Department of State.

4. Place of Business. The mailing and street address of the Company's principal office is 2995 41st Street S.W., Naples, Florida 34116.




