ORDER GRANTING LIOUIDATING TRUSTEE'S MOTION TO (I) APPROVE DISTRIBUTION TO THE MEMBERS OF CAPITAL PLACE FUNDING, LLC, AND (II) FOR JUDICIAL DISSOLUTION OF CAPITAL PLACE FUNDING, LLC, CAPITAL PLACE, LLLP, AND AMERICAN CAPITAL PARTNERS, LLC

THIS MATTER came before the court on July 31, 2007 upon Kenneth A. - 4. A decree of judicial dissolution of Capital Funding is hereby entered by the Court.
- 5. A decree of judicial dissolution of Capital Place is hereby entered by the Court.
