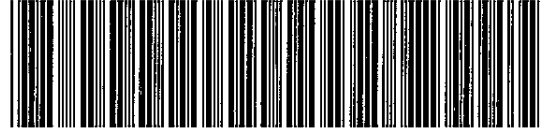

ARTICLES OF ORGANIZATION
OF

The undersigned, who is duly licensed to practice law in the State of Florida, desiring to form a limited liability company in accordance with Chapter 608 of the Florida Statutes and the Florida Professional Service Corporation and Limited Liability Company Act, Chapter 621 of the Florida Statutes, adopts the following Articles of Organization:

ARTICLE I

Name

The name of the limited liability company ("Company") is Law Offices of John DeLancett, P.L.

ARTICLE II

Address

The mailing and street address of the Company's principal office are 4713 Jetty Street, Orlando, Florida 32817.

ARTICLE III

Duration

The period of duration for the Company is perpetual.

ARTICLE IV

Purpose

The general purposes for which the Company is organized are the following:

A. To engage in and transact any lawful business for which a limited liability company may be organized to practice law under the Florida Professional Service Corporation and Limited Liability Company Act.

B. To do such other things as are incidental to the purposes of the Company or necessary or desirable in order to accomplish them.

ARTICLE V

Professional Services

The professional services of the Company shall be rendered only through members, employees and agents who are duly licensed or otherwise legally authorized to practice law within the State of Florida. Professional services shall be rendered in each case by the member, employee or agent designated solely by this Company, acting through its managing member. This provision shall not be applicable to the extent it is in conflict with the law or the professional rules of legal practice.

ARTICLE VI

Registered Agent and Office

The name of the Company's initial registered agent in Florida is Hendry, Stoner, DeLancett & Brown, P.A. The address of Company's registered office in Florida is 20 N. Orange Avenue, Suite 600, Orlando, Florida 32801.


