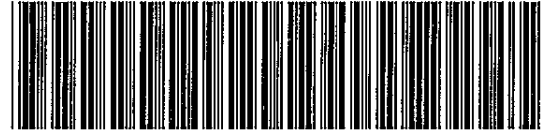

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

Article I - Name

The name of the limited liability company shall be **CODY LOWRY GOLF 2005, LLC** ("Company").

Article II - Principal Place of Business and Address

The principal place of business and the address of the Company in Florida shall be 1501 South Florida Avenue, Lakeland, Florida 33803, and its mailing address is the same.

Article III - Duration

The Company shall have perpetual duration.

Article IV - Purposes and Powers
