# ARTICLES OF ORGANIZATION OF

BAR R RANCH.L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

## **ARTICLE I**

#### NAME

The name of the limited liability company shall be Bar R Ranch, L.L.C. ("Company").

#### ADMISSION OF ADDITIONAL MEMBERS




