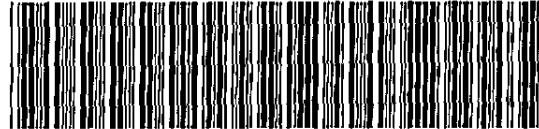

ARTICLE FIVE - Admission of Additional Members:




