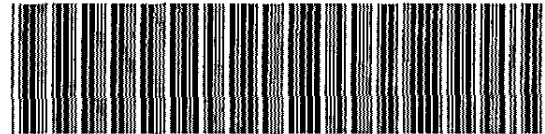

ARTICLE I
(Name)


ARTICLE V


