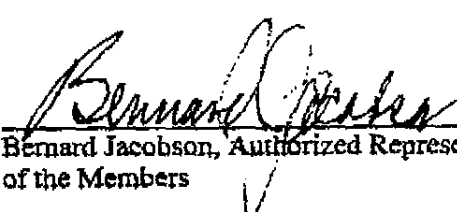
**ARTICLES OF DISSOLUTION
