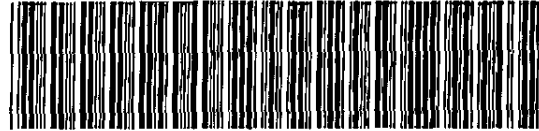

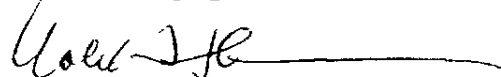

**AMENDED ARTICLES OF ORGANIZATION
OF
A & P GROUND WORKS, LLC**

The undersigned, for the purpose of forming a single member limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, does hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be **A & P GROUND WORKS, LLC** ("Company").

ARTICLE II -- ADDRESS

The street address of the principal office of the company shall be 101 S. U.S. Highway 1, Oak Hill, Florida 32759 and the mailing address is 173 East Church Street, Oak Hill, Florida 32759.

ARTICLE III -- DURATION

The company shall commence its existence on the date the articles of organization were filed by the Florida Department of State. The company's existence shall be perpetual.

ARTICLE IV -- REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the company in the State of Florida is **Virginia M. Allen** at 173 East Church Street, Oak Hill, Florida 32759.

ARTICLE V -- CAPITAL CONTRIBUTIONS

The member of the company shall contribute all of the capital of the company in cash or property.

ARTICLE VI -- ADDITIONAL CAPITAL CONTRIBUTIONS

The member shall make additional capital contributions to the company as the member determines necessary.

ARTICLE VII -- ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the company except with the written consent of the member of the company and on such terms and conditions as shall be determined by the member. The company shall be dissolved on the death, bankruptcy, or dissolution of the member or on the occurrence of any other event that terminates the continued membership of the member in the company.

ARTICLE IX -- MANAGEMENT

The company shall be managed by the member in accordance with regulations adopted by the member for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization. 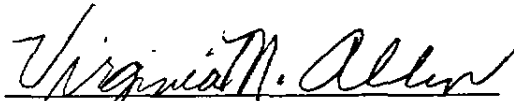
