ARTICLES OF ORGANIZATION
OF

The principal office and mailing address of the Company is 475 Commerce Lake Drive, Suite 108, St. Augustine, Florida 32092.

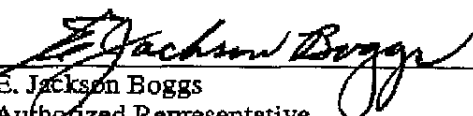
ARTICLE III
