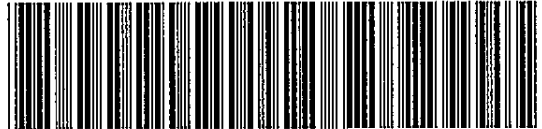

ARTICLES OF AMENDMENT TO THE  
ARTICLES OF ORGANIZATION OF

under Section 608 of the Florida Statutes

**THE UNDERSIGNED**, for the purpose of amending the Articles of Organization of POAL WK TAFT LLC (the "Company"), pursuant to Section 608 of the Florida Statutes, does hereby certify and set forth:
