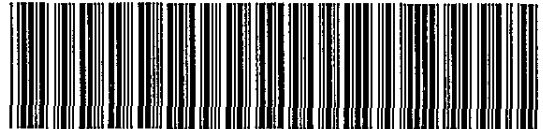

ARTICLES OF ORGANIZATION
of
