ARTICLES OF ORGANIZATION OF 4995 A1A, LLC

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

Article 1 - Name

The name of this limited liability company is 4995 A1A, LLC ("Company").
