## ARTICLE VI

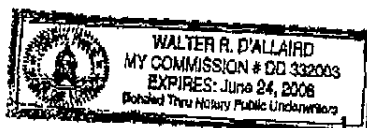



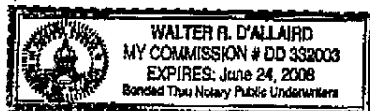
