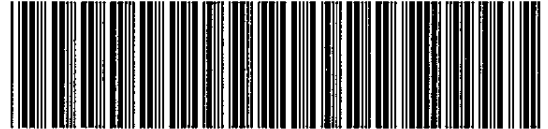

ARTICLE III - MANAGEMENT


The Limited Liability Company is to be managed by one or more members, and is, therefore, a member managed company. The initial manager member is John T. Mongoven.

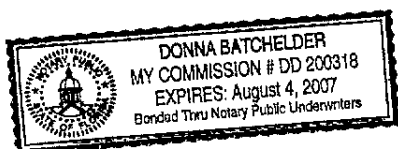


