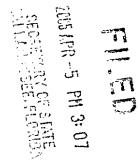

ARTICLES OF ORGANIZATION OF BEAR CROSSING INVESTMENT, LLC

The undersigned hereby forms and establishes a limited liability company under the laws of the State of Florida.
