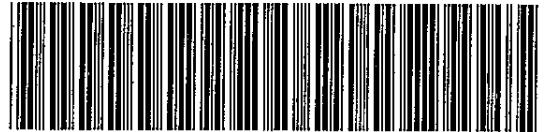



**ARTICLES OF ORGANIZATION  
OF  
BEAR CROSSING INVESTMENT, LLC**

The undersigned hereby forms and establishes a limited liability company under the laws of the State of Florida.

**ARTICLE I**

The name of this limited liability company is BEAR CROSSING INVESTMENT, LLC ("Company").
