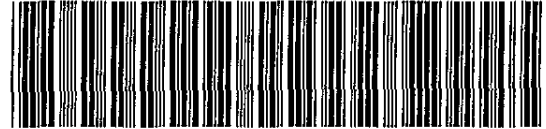

ARTICLES OF ORGANIZATION

A LIMITED LIABILITY COMPANY

1. Name. The name of the limited liability company is Remar, LLC.
