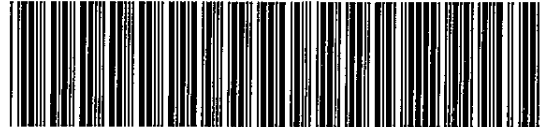

**ARTICLES OF ORGANIZATION
OF
MARAMORA LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be Maramora LLC ("Company").

The undersigned authorized representative of the member has executed these Articles of Organization at Sarasota, Florida, on this 1st day of April, 2005.



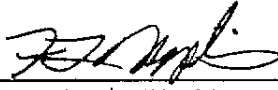
