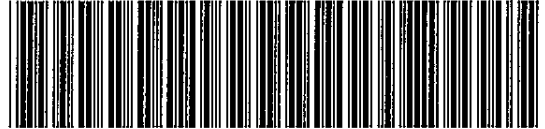

**ARTICLES OF ORGANIZATION

MANAGEMENT OF THE COMPANY**


Management of the Company shall be vested in a manager and is, therefore, a manager-managed company.
