**ARTICLES OF AMENDMENT TO THE
ARTICLES OF ORGANIZATION
OF
BRANTLEY HEIGHTS, L.L.C.**

Pursuant to the provisions of Section 608.411 of the Florida Statutes, the undersigned Limited Liability Company adopts the following Articles of Amendment to its Articles of Organization.

1. The date of filing the Articles of Organization was April 7, 2005.
2. Article I is deleted in its entirety and the following substituted in lieu thereof:

"The name of this limited liability company shall be LRA, L.L.C., a Florida limited liability company."

3. Article IV is deleted in its entirety and the following substituted in lieu thereof:
