ARTICLES OF ORGANIZATION OF BG REAL ESTATE, LLC

1. NAME. The name of this limited liability company is BG REAL ESTATE, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.

2. PLACE OF BUSINESS. The mailing address and street address of the Company's principal office is 601 Bayshore Boulevard, Suite 650, Tampa, Florida 33606.
