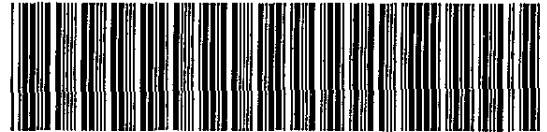

Article I of the Articles of Organization of SACKETT REALTY, LLC., a Florida limited liability company (L05000034153), is hereby amended to read as follows:




