

RESTATED & AMENDED ARTICLES OF ORGANIZATION For PROPCORP, LLC.

The undersigned a limited Liability Company under the laws of the State of Florida, and hereby sign, verify and deliver to the Secretary of State of Florida this Article of Organization

ARTICLE I

Name

The name of the limited liability company shall be PROPCORP, LLC, a limited liability company ("the LLC").

ARTICLE II

Period of Duration

The LLC shall have perpetual existence beginning on the date that the Articles of Organization are filed and after the date the Florida Secretary of State issues a certificate of formation, unless dissolved according to law.

ARTICLE III

Purpose of the LLC

The purpose of the LLC shall be to engage in the lawful act and activity of providing Real Estate investment and management services as permitted under the Limited Liability Law of Florida.

ARTICLE IV

Registered Agent and Office

The address of the initial registered office and the principal place of business of the LLC is 20094 Palm Island Drive, Boca Raton, FL 33498. The registered agent is Lawrence Reznik

ARTICLE V

Members Contribution

The members contribution to the LLC in the form of cash and stock and represent the following percentage ownership in the LLC:

Seglo Realty LLC

50%

Elad Realty LLC

50%

Unless all members agree in writing, no member shall have any obligation to make any additional contributions to the LLC.

ARTICLE VI

Additional Members

The existing members have the right to admit additional members to the LLC upon such terms and conditions as the existing and additional members shall agree at their sole discretion. Any member who is subsequently admitted as a member of the LLC shall have all the rights and obligations of a member under the "LLC Operating Agreement."

ARTICLE VII

Continuation of Business

In the event of death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of an event which terminates the continued membership of a member, the LLC shall dissolve and terminate, unless all the remaining members of the LLC agree to continue the business of the LLC.

ARTICLE VIII

Manager

Mark Segal and Lawrence Reznik who shall serve in such capacity pursuant to the LLC Operating Agreement shall manage the LLC.

ARTICLE IX

LLC Operating Agreement

The regulation of the internal affairs of the LLC is more particularly set forth in the LLC Operating Agreement.

ARTICLE X

Transferability of Interest

No interest in the LLC may be transferred except as specifically set forth in the LLC Operating Agreement.
