# ARTICLES OF ORGANIZATION OF Q&C, LLC

The undersigned authorized representative hereby executes these Articles of Organization ("Articles") for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

#### ARTICLE I

## Name

The name of this limited liability company (the "Company") shall be:

The Company's existence shall commence on and as of April 4, 2005, provided that these Articles of Organization are filed with and by the Florida Department of State within five (5) business days after such date.
