#### ARTICLES OF ORGANIZATION

OF'

#### McCollom Video Productions, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I -- NAME

The name of the limited liability company shall be McCollom Video Productions, L.L.C..

#### ARTICLE II -- ADDRESS
