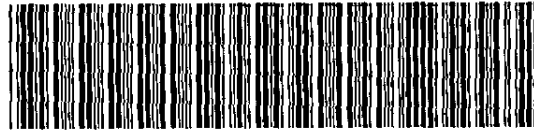



THIS IS TO CERTIFY THAT:


FIRST: This Article amends the Articles of Organization of Mosaic Properties, LLC.
