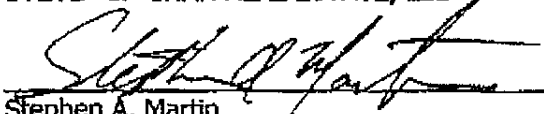

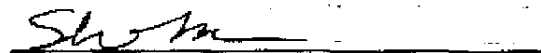
2. Article V of the Articles of Organization of said limited liability company shall be amended as set forth in Exhibit "A" hereto.
