
ARTICLE XVIII

The power to amend the Regulations is reserved exclusively to the unanimous vote of the members.

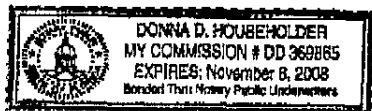
