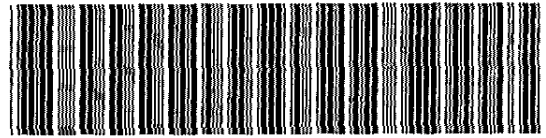

ARTICLES OF ORGANIZATION

Of

ARTICLE I

Name and Duration

Management
