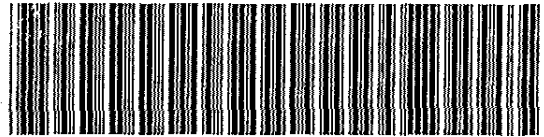



This Limited Liability Company reserves the right to amend, alter or repeal any provision contained in the Articles of Organization by the unanimous vote of the members.


