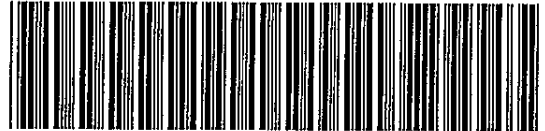

ARTICLES OF ORGANIZATION
OF

ARTICLE I
Name of Company

Network System Solutions, LLC

ARTICLE II
Business of Organization

The limited liability company may engage in the business of computer networking, consulting, maintenance, installation and service of computer systems, and may also engage in any other lawful activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III
Principal Place of Business

The principal place of business of the limited liability company shall be: 2315 Cricket Road, Middleburg, FL 32068, and the mailing address shall be the same.

ARTICLE IV
Duration

The existence of this limited liability company shall commence upon the filing of these Articles of Organization with the Florida Department of State, and thereafter it shall have perpetual existence.

The member(s), if any, remaining after the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or any other event which terminates the membership of a member, have the right to continue the business of this limited liability company subject to approval by the unanimous vote of the remaining member(s); provided that there is at least one remaining member.
