The name of the company is HAWAII KO OLINA KAI S17, LLC, a Florida limited liability company (the "Company").

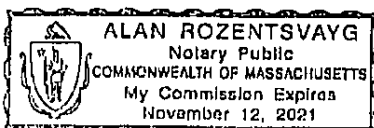
